Director Cox also shared that senior services had been very strong the past 8-10 weeks in particular, with monthly outreach bags now at 45 and the weekly chair yoga program bringing in 10-15 participants from a wide range of communities.

Holiday décor for the Story Walk had been added recently, and the new story is to be installed around 11/28. Finally, furniture for the circulation area is scheduled to be installed 11/17 in the morning. This represents the last significant portion of the Phase 1 remodel to be completed.

Trustee DeFord asked if the rear exterior door noted as being in poor condition had already been considered in planning.
